CODE OF ETHICS (RESEARCH)

1.0 Preamble

St. Joseph's College of Arts and Science (Autonomous) nurtures the publication of high-quality research papers. It also expects the researchers to publish their findings appropriately to their respective academic discipline. The management entails all the authors/researchers responsible for the publication of their contents and recognise their contribution.

2.0 General code of ethics

- **2.1** The researchers should encompass appropriate consideration of ethical issues into the design and management of projects. Those who involve with human samples or communities, environment or animals must get proper ethical permission with respective statutory bodies either within the college or with other institutions if such bodies are not available in the college. The research proposals must have to undergo these committees/bodies before carrying out the research.
- **2.2** The researchers must address the questions of approval/consent, power relations, deceit, confidentiality and secrecy in any review/investigative project in order to keep regard of the human rights and the formalities of all who are involved in that project.
- **2.3** The research scholars must maintain respectful and ethical relationship with peer partners and with research supervisors.
- **2.4** All the PhD theses are to be checked by Plagiarism Checking Software before submission and certificate to be submitted with signatures of both research scholar and the concerned research guide. Plagiarism software has been provided to the entire faculty for checking their research articles, research proposals and research project reports.
- **2.5** Information and/or complaints regarding the above issues, shall be referred to the committee constituted by the Principal for necessary action.

3.0 Misconduct in research

Alteration, fabrication, or fraudulence in creating or reporting laboratory results, research results, and/or any other tasks; sexual harassment of other scholars; contacting the examiner about thesis evaluation are the mode for misconduct.

3.1 Misconduct of Scholars

- 3.1.1 Submitting plagiarized results/work for an academic requirement.
