The faculty of respective two colleges will take classes by exchanging faculty with mutual agreement on their free time. It can be done once in a week or once in a month through online or offline or in blended mode (online / offline).

2. Student Exchange Programme

Students of respective two colleges will be visiting the each other colleges in order to promote student cooperation and to get new exposure. PG & M.Phil. students can be take part in activity of teaching to enhance their role of teaching.

3. Collaborated Activities

Activities like Seminars, Conferences, Workshops, Capacity Development Programmes (CDP), Professional Development Programmes (PDP), Faculty Development Programmes (FDP) or any other academic oriented programmes can be conducted collaboratively.

The specific areas and details of cooperation within the framework of this Memorandum of Understanding (MOU) shall be discussed and agreed upon in writing by the appropriate authority of each Institution, prior to the initiation of any particular programme or activity by institutions. No binding agreement between the Institutions shall exist unless and until such a formal written agreement is executed.

Termination of MOU :

Whilst this MOU creates no binding obligations on the two colleges, the MOU shall become effective from the date of the last signature and remain in force for a period of three (3) years with the understanding that it may be terminated by
